

MINUTES OF S.G.M. OF RAJASTHAN ATHLETIC ASSOCIATION CONVENED ON 30.11.2025 ARE AS UNDER:

The SGM is being conducted in pursuance of notice dated 14.11.2025 issued by Shri Dev Narayan Gurjar, Secretary of the Association to discuss the Agendas mentioned in notice dated 14.11.2025 at Urban Suites by Blusalz (Venue changed vide corrigendum dated 29.11.2025). The present SGM is attended by 24 District Athletic Associations, attendance sheet attached, along with President and Secretary of the Association.

WELCOME NOTE

The President and Secretary, Rajasthan Athletic Association warmly welcome the attendees who are present in pursuance of notice dated 14.11.2025. The meeting is chaired by President of the Association Smt. Sharda Devi Jadam. With her permission, the Agendas will be discussed.

DISCUSSION ON AGENDA

1. To confirm the minutes of last AGM held on 27.4.2025 at Jaipur.

Shri Dev Narayan Gurjar, Secretary of RAA informed the members that the minutes of previous AGM dated 27.4.2025 held at Jaipur were provided to all the affiliated District Units. The affiliated District Units present in the meeting approved the same and henceforth confirm them as no objection to the minutes of the said meetings are received or raised from any of the present members. Thus the said minutes are approved with vocal unanimous majority as proposed by Shri Om Puri and seconded by Shri Rakesh Sharma.

2. To discuss and approve the annual calendar for the upcoming session of 2026.

It was discussed that RAA should finalize the calendar in line with Athletic Federation of India. The members discussed in detail for each and every competition. It is decided to finalize the calendar in line with the Calendar of Athletic Federation of India. Few of the events finalized are Rajasthan State Sr. Athletic Championship 2026 at Bikaner between 25 May to 6 June, 2026; Rajasthan State Jr. Boys Athletic Championship; Rajasthan State Jr. Girls Athletic Championship, both at Bharatpur between 16.8.2026 to 31.8.2026; Rajasthan State Under 23 Athletic Championship at Sikar in the month of September 26; Rajasthan State Cross Country Championship 2026 at Niwai / Tonk in the month of December, 2026. To hold open meets of 400 meters, jumps, throws, and relay will be decided after the issuance of circular for tournaments by Athletic Federation of India.

The abovementioned schedule was approved by unanimous majority as proposed by Shri Giriraj Sankhla and seconded by Shri Bhupendra Singh.

3. To discuss and decide over some District Unites regarding their non compliance of Rajasthan Sports (Registration , Recognition and Regulation of Association) Act, 2005 as per the Constitution of Rajasthan Athletic Association.

District Bhilwara:

Regarding District Athletic Association Bhilwara, selection committee was formed in last ECM. The said selection committee has been recommending names of players. The office bearers of the said District have not convened fresh election after expiry of their tenure and therefore in the interest of players, selection committee was formed. The

players selected by the selection committee have been duly participating in the tournaments organized by RAA.

District Bharatpur:

The election of District Athletic Association Bharatpur were not convened after expiry of tenure of the last executive. The representative of the said District Association namely Shri Sirmohr Gurjar is present. On his request, earlier also letter was written to Dy. Registrar Cooperative Society Bharatpur for formation of ad-hoc committee. The said letter is still pending consideration. It is resolved to issue fresh letter to Dy. Registrar, Bharatpur for formation of Ad-hoc Committee.

District Alwar:

Show cause notice was issued to District Athletic Association Alwar to explain regarding the illegalities Prevailing in the said District Athletic Association. From record it revealed that a PIL (Writ) No. 2348/21 was filed before Hon'ble Rajasthan High Court at Jodhpur titled as Abhijeet Choudhary and others vs State of Rajasthan and others. To submit factual report before the Hon'ble High Court, record of numerous Districts was called for and in that exercise, it revealed that for last six years, the Alwar District Athletic Association is not performing its activities of sport as well as election, as per the Rajasthan Sports Act, 2005. Because of the dispute in the said Association, the players of the District are not getting Government Allowance, TA, DA since year 2019 because of non-recognition of the District Sport Council. The players of many others Districts are getting the same. Thus because of dispute in the Association, players are heavily suffering. The Registrar also conducted inquiry and found that the Association was guilty of not conducting its affairs as per the provisions of Rajasthan Sports Act. After inquiry it was found that the previous office bearers elected on 12.3.2023, were not elected validly and were including clubs/primary sports body in an illegal manner. The previous office bearers committing the said illegality are the then Ramphal Saini (Ex-Secretary) who has been holding post since year 2006 after the alleged registration under Sports Act. Though he claims to be the Secretary since 2002. The election of 2023 was set aside by the Registrar. Thus the said illegal body elected in the year 2023 has failed to fulfil the duty of properly selecting team. The Rajasthan Athletic Association has received numerous complaints from different players regarding their illegal exclusion in the selection trial and selection of players at the sweet will of Mr. Ramphal Saini. Ramphal Saini either charges money from players for selection or selects player close to him or his known persons. Thus for many year there has been no fair selection of players in Alwar District. The illegal act of Ramphal Saini is also proved from letter of two members of the Ad-hoc committee appointed by Dy. Registrar, Alwar, who resigned from their post on 10.8.2025. The said members were CA Shri Kishan Gupta and Nisha Yadav, who submitted their resignation to Dy. Registrar Cooperative Societies Alwar. In the said resignation it is clearly stated that entire ad-hoc committee is being governed by the illegally elected previous Secretary Ramphal Saini. Ramphal Saini who is present today was asked to explain the abovementioned fact. He was also asked to explain the illegalities in the last election of the Association held on 31.8.2025. No explanation has been submitted before the General Body today. The letter / communications issued by Rajasthan Athletic Association to Secretary, Department of Sports and Youth Affairs, Registrar Co-operative Societies, Government of Rajasthan, Dy. Registrar Co-operative Societies Alwar, Office of Hon'ble Chief Minister, Government of Rajasthan; the election notice issued for the said election by the election officer, the proposal to charge fee for selling the election form mentioned in the notice, the report of observer of RAA Shri Surendra Singh Gurjar for the said election and other material

placed on record was duly considered and duly presented before the House and the same was discussed in detail. Shri Ramphal Saini was asked to explain the said illegality including the fact that the said election process was undertaken without calling for Annual General Meeting. Shri Ramphal Saini did not tender any explanation and rather stated that election process was undertaken in a valid manner. Only one District Association i.e. Jaipur District Association through its representative Shri Gopal Saini supported Shri Ramphal Saini and stated that certain irregularities in the said election are required to be ignored. The remaining members of the house are of unanimous opinion that the illegalities committed in the last election of Alwar District Athletic Association and the manner in which office bearers have been elected is completely against their own constitution, constitution of RAA and provisions of the Rajasthan Sports Act, 2005. It was highlighted that the election notice was issued without accompanying copy of audited accounts. On the date of holding election i.e. on 31.8.2025 the said association was having registration certificate under the provisions of Cooperative Act, 1958, it was not registered under the provisions of the Act of 2005. The District Alwar is acting in collusion with Shri Ramphal Saini for which complaint has already been made to the Hon'ble Chief Minister of Rajasthan and in these circumstances, the illegally elected officer bearers will cause serious prejudice to the players of the athletic in the Alwar District. Even the Constitution of Alwar District was placed before the members and it was found that the elected members as mentioned in election certificate dated 31.8.2025 are not as per constitutions. As per section 8 of the Act of 2005, it is mandatory that every District Association shall incorporate provisions for abiding by decision or directions of concerned State Level Association. Such provisions is also missing in the constitution of DAA Alwar. It was also brought to the notice of the house that the selection committee of Shri Captain Umrao Lal Saini (Ex-Army Officer, International Athletic, International Refry and International Coach), Shri Sabal Pratap Singh (International Coach, Retired Athletic Coach) and Shri Dhara Yadav (International Athlete). has already been constituted and undertaking the selection process for District and State Level Tournaments. It was also brought to notice of house that show cause notice was given to Shri Ramphal Saini on 15.11.2025 which was duly served upon him and in compliance of which he is present before this House.

In the above-mentioned circumstance, the entire house / members present except for Shri Gopal Saini of Jaipur District Athletic Association approve the proposal for disaffiliating the said District Association as member of Rajasthan Athletic Association.


District Jalore:

The house is informed that the office bearers of District Unit have already written letter to Dy. Registrar Jalore for formation of ad-hoc committee as the election of the said association were not convened within time pursuant to expiry of tenure of the previous elected body.

The abovementioned proposals were proposed by Dr. Ram Niwas and seconded by Hari Ram Choudhary and unanimously agreed as mentioned above.

4. To discuss the performance of Athletes in national Meets.

The Rajasthan State Sports Council will be requested to provide modern quality equipment's for athlete sports like Javelin, discus, shotput, high jump pit, pole vault pit, spikes and pole etc. for all the players. Sports Council will be requested for arranging of funds and request State Government for special attention for providing abovementioned material. The said modern equipment are required for better performance of player at National Level Tournaments. It is also resolved to take advice

from qualified nutritionist and cyclising specialized in the field of sports to provide better nutrition to the player and to make them mentally strong. It is also proposed to prepare list of doctors specialized in sports injuries so that in contingency, they can be approached without wasting valuable time. The aforesaid is proposed by Shri Deva Ram Choudhary and seconded by Shri Swadesh Mittar which is unanimously agreed and approved by the house.

5- Any other business with the permission of Chair.

Since there was no any other item on the agenda, the meeting ended with a vote of thanks to the chair.
